Movement of DPD/DPE containers between CONCOR TNPM and CONCOR HOM Annexe.

CONCOR is pleased to inform that Chennai Customs has issued facility circular no. 16/2018 dated 16/03/2018 as 24 x 7 for DPD/DPE. Accordingly, as per the facility circular:

1. CONCOR Tondiarpet (TNPM) has been declared as "designated CFS" for DPD containers, where in containers lying beyond 02 days in Port may be moved to CONCOR, TNPM as per Customs facility circular 22/2017 dated 01/11/2017.
2. The Importers who wish to move their DPD containers shall give advance intimation to shipping lines for filing DPD destination code as "DPD CON1" in the IAL. CONCOR will move these DPD containers by Rail from HOM to TNPM and in return DPE containers will be moved to HOM.

The charges for the above movement of containers between CONCOR TNPM and CONCOR HOM-Annexe are as under.



1. The Port related charges (Haulage & Port Service Charges Rs.27.29 per MT) are exempted for DPD/DPE movement between HOM and TNPM by RAIL. DPD includes Enbloc also.
2. The above rates are applicable for Rail loading at CONCOR HOM-Annexe to TNPM and from TNPM to HOM-Annexe.
3. A free time of 10 (Ten) days including date of arrival at TNPM, for both Import/Export containers.
4. All charges for Import/Export will be collected at TNPM end only.
5. The Port terminal inter carting charges will be paid by the Shipping lines directly to Port Terminals as applicable.
