Subject: Kamarajar Port Limited- Port Reception facilities for Garbage
(Annexure V of MARPOL 73/78)- Intimation Reg.

Sir,

Kamarajar port Limited has facilitated Port reception facility for disposal of Garbage (Type of Wastes: Category 1 to 5) and made mandatory for all the vessels calling to Port for cargo operations to dispose solid waste upon berthing.

Port has engaged a contractor through open tender system during July 2015 for the collection and disposal of Garbage from the ships berthing at Port. Port will charge an amount of Rs.936/- plus GST, per cubic meter towards the charges and service rendered for the purpose of removal of garbage from the ships. Any additional quantity of waste is required to be disposed on demand, the same will be charged extra @ 936/- plus GST, per cubic meter. The quantity of solid waste collected from the ships will be charged on actual basis subject to a minimum of one cubic meter per call whether garbage is disposed or not.

Port will raise the bill for the collection of garbage only to the ship's agent. The contractor will get endorsement from the Master of the vessel or his representative as a proof for his visit and the for the quantity disposed, and a receipt will be issued.

Master of the vessel may be advised to segregate the wastes before disposal and also to ensure that radioactive substances, hazardous material, banned items or any items of commercial value are not disposed from the ship.
